The Legal Aid Society of Greater Cincinnati has been providing legal services in our community for over one hundred years through legal representation, information, advice and referral for people in need of legal help.

The VLP was co-founded by the Legal Aid Society of Greater Cincinnati and the Cincinnati Bar Association. Legal Aid works with the VLP to provide high-quality legal services to low-income citizens in seven southwest Ohio counties: Brown, Butler, Clermont, Clinton, Hamilton, Highland, and Warren. The VLP recruits private attorneys to handle at least two pro bono cases each year. Cases handled by volunteer lawyers are common to a general civil practice and may require anything from limited advice in a clinic setting to full-scale representation.
